Multi-Student Discounts

- The first (oldest) student will be charged full tuition.
- The second child in the same family will receive a 10% discount on tuition.
- All additional children (3+) in the same family will receive a 20% discounted individual tuition.

Tuition Assistance Requirements

Families may apply to multiple *Student Tuition Organizations (STOs)* **OR** utilize the Arizona Department of Education's *Universal Empowerment Scholarship Account (ESAs)* to resolve most or all their tuition depending on the family's circumstances. It is the responsibility of families to submit applications for STO or ESA funding, meet deadlines, and follow all the relevant guidelines and policies of the STOs and the Arizona Department of Education to access funding. Families will be **required** to submit either proof of a valid ESA contract, or proof of having applied to each of the STOs that our Christos schools accept prior to your student being allowed to participate in class.

Tuition Payment Policy

- The first payment is due August 1st, and subsequent payments are due on the 1st of each month. Please note that August's tuition will still be due on the 1st even though school starts later in the month.
- The parent/guardian will be invoiced the monthly tuition amount. It is the responsibility of the parent/guardian to ensure monthly tuition invoices are paid, regardless of their application for support.
- Any assistance from ESA or STO will be applied as a payment or credit toward the monthly tuition as it is received. **Parents are responsible for the 2% ClassWallet transaction fee** when using the state online platform. ESA (state assistance) payment frequency is inconsistent and therefore invoices to ESA must be submitted within the first week of receiving the monthly invoice.

Delinquent Accounts

- Accounts that are delinquent may result in the student not being allowed to attend class until the account is brought current or arrangements and a written payment plan have been approved by the Christos Billing Specialist.
A delinquent account is described as:
 - 2 months (60 days) of unpaid tuition in BrightWheel
 - 2 months (60 days) of unpaid learning plan costs in Configio (if applicable)
 - Parent/guardian has not attempted to remedy the situation by contacting the Christos Billing Specialist

Student Withdrawals

- When a student is voluntarily withdrawn from Great Hearts Christos for *any reason*, at any time, the parent must notify Administration in writing at least one (1) week prior to the withdrawal date. A formal Withdrawal Form must be completed, signed, and submitted. An email message to Administration from the parent's email address on file is an acceptable written form of notification to the school.
- If you withdraw your student, please be advised we do not prorate the monthly tuition amount due based off the number of days attended in the month of withdrawal. The full month's tuition remains due. Please keep this in mind if you wish to withdraw.
- At the time of withdrawal, parents have a contractual obligation to satisfy any outstanding accounts
